RE: REQUEST FOR QUOTATION FOR THE DRILLING, TESTING AND EQUIPING OF BOREHOLE AT SEEMA HALL.

QUOTATIONS are invited from all the potential service providers who are keen to Drill, Test and Equip Borehole at Seema Hall as per the specification. The advertisement is only valid for **SEVEN** days.

The service providers must attach the following to their quotations:

1. Company profile (Compulsory);
2. Original Valid Tax Clearance Certificate (Compulsory);
3. Recent proof of municipal rates and taxes from the billing municipality/recent proof of residence from traditional authority (not older than 3 months)/valid lease agreement and Municipal rates and taxes of the Landlord (Compulsory);
4. Copy of Company Registration Certificate (Compulsory);
5. Certified ID copies of business owners (certification not older than 3 months) (Compulsory);
6. Valid B – BBEE Verification Certificate (No submission will be allocated zero (0) points);
7. CIDB Grading: 1GB.

NB: Failure to submit all of the above attachments shall lead to the service provider being disqualified.

SPECIFICATION

TECHNICAL SPECIFICATION FOR THE DRILLING, TESTING AND EQUIPMENT OF BOREHOLE AT SEEMA COMMUNITY HALL

PART 1

Borehole specifications

Boreholes must be drilled to a final diameter of 165mm and to a maximum depth of 120m.

Drilling specifications

The final borehole diameter shall be 165mm and must be drilled and cased straight and vertical and all casings and liners shall be set round, plumb and true to line.

PART 2

Testing Specifications Pump and chemical test

Diameter of borehole is mainly 165 mm with yield ranging from 0.1l/s to 20l/s. The test pumping will include four one-hour step test followed by a 24- hour constant rate test and 24- hour recovery test (or to 90% recovery).

PART 3

Equipment of borehole

Submersible pump complete with steel manhole cover

PART 4

Supply and Installation of:

- a) 1 x 5 000 litres Jojo tank
- b) 1 x 4.5m stand
- c) Electrical connection
- d) Commissioning

EVALUATION CRITERIA:

Preferential Procurement Policy Framework Act No. 5 of 2000: Preferential Procurement Regulations 2011 and Supply Chain Management Policy of Aganang

Local Municipality will apply in the evaluation and adjudication process. The evaluation of the acceptable proposals will be conducted in the following stages:

Firstly, will be the administrative requirements.

Thereafter by using a system that awards points on the basis of 80 points for proposal price and 20 points for status level B – BBEE. Original or certified copy of B – BBEE Certificate must be submitted, In case of a joint venture a joint B –BBEE should be submitted.

Bidders who do not submit B – BBEE Status Level Verification Certificates or are non-compliant contributors to B – BBEE do not qualify for preference points for B – BBEE but will not be disqualified from the bidding process. They will score points out of 80 for price only and zero points out 20 for B – BBEE.

The service providers must take note of the following information:

1. The closing date for the advert is 11th November 2013 @ 12H00.
2. Compulsory briefing session will be held on 05th November @ 10H00 at Aganang Municipal Chamber.
3. Quotation documents will be available from the 04th November 2013 at Aganang Municipal Office (Ceres) at a non-refundable fee of **R50.00** (VAT inclusive).
4. The quotations must be deposited in the tender box which is accessible from 8H00 to 16H30 Monday to Friday at the foyer of the municipality on/or before the closing date and time as stipulated above.
5. Only the service providers with the capacity to Drill, Test and Equip Borehole are welcome to forward their quotations.
